# **Yealmpton Bowling Club**

Minutes of Management Committee Meeting held at the Clubhouse on Thursday 15 February 2018 at 1030hrs.

#### Chairman's Introduction

Fred thanked Officers for their contributions, especially Mark for the green, Roy for organising the Christmas dinner & John Osborne for the fixture list and the website, which now had a feature allowing members to put their names down for matches (although the exact procedures for this still had to be worked out). He also welcomed Jim back from his recent illness. Articles about the Club were to be made in Parish Magazines for March & April.

**2. Minutes of Management Meeting** held on 19 October 2017 were accepted.

#### 3. Matters Arising.

Bob raised a number of items outstanding from previous meetings:

- The proposed Social Committee has been shelved for the present;
- A change to the rules (regarding wearing of Club shirts) had been agreed at the AGM. Bob would circulate a note to ask members to annotate their copy of the Rules until more copies are ordered (probably next year);
- The proposal to change the Rules on the Husband & Wife Competition to make it 3 wood pairs was not accepted;
- Discussions to be held on next season's BBQ & Christmas meal;
- Refurbishment of the back wall of the clubhouse was still to be resolved.

### 4. Secretary's Report.

• S106 funding – the new path had been completed, the base for the shed will be laid this weekend & the shed delivered and erected the following week;

- Moneys had also been granted by South Hams Council and the Parish Council for further storage units; it is also planned to place some lighting on the outside of the Clubhouse from the S106 grant.
- Yealmpton Athletic Association the Duck Race will be held on 15 July and the Sports Gala on 9 September. It was also hoped to organise a "Spring Event" in early May.
- The Association has also bid for a grant from the South Hams Community Re-Investment Project to extend the car park and to replace fencing on 2 sides of the bowls club.
- The Committee discussed ways of encouraging more entrants into Club competitions to be referred to Spring Meeting;
- The Honours Board had been updated to reflect last season's results:
- Patrons Rules had been changed to allow more flexibility. Bob would act as co-ordinator for next season

#### 5. Treasurer's Report.

The Club currently held £9400 in the bank. It was agreed to keep fees at the same level as last year.

The Committee discussed the situation where a member is unable to play for a complete season eg due to illness. It was agreed that the Constitution adequately covers the situation (para. 4.4). If the situation occurs after payment of the year's subscription, the member should write, via the Secretary, to the Committee who will give sympathetic consideration to a refund.

### 6. Fixture Secretary.

In John's absence, Fred reported that the Fixture List had gone to the printers and would be available at the Spring Meeting.

# 7. Match Secretary's Report.

Jim said all fixtures in place and had nothing further to report.

### 8. Green Marshall's Report.

The green was in good order following a wet winter. Mark had a green team of 7 members, but is looking for one more. Pay will be in donuts as last year.
