#### 1. Apologies.

#### 2. Minutes of Management Meeting.....

#### 3. Matters Arising.

The proposal by Pat for a historic Honours Board was being pursued by Bob; there were a number of options being considered..

#### 4. Secretary's Report.

Annual signed statements by all members were required under the new GDP Regulations; Bob would produce a form to be signed by members when they rejoin each year. Bowls England require all Clubs to have a Safeguarding Officer & a Safeguarding Policy (draft prepared). Request for a volunteer Officer would be made at the Spring Meeting. There was a number of jobs required around the site & Bob would arrange a work day. The collection made in lieu of Christmas cards raised £78 which was donated to the Shekinah Mission, the Charity selected by the President.

## 5. Treasurer's Report.

John had taken over the duties of Treasurer and reported a healthy balance in the bank £10,600. It was agreed that membership fees would remain the same this year (£88).

# 6. Fixture Secretary's Report.

It was agreed that for the 2020 season the start date would be Saturday 4<sup>th</sup> April with a "Roll up" on Saturday 11<sup>th</sup> April and the closing date would be Sunday 4<sup>th</sup> October,

This year we are hosting the Devon Presidents Mixed Team (6 rinks) on 6<sup>th</sup> June and also the Devon Patrons Mixed Team (5 Rinks) on 24<sup>th</sup> June. Bob said he had suggested to Bowls Devon that Marcia be presented with her Merit Award at the Presidents match; a response is awaited from Bowls Devon Lady President.

It has proved impossible to arrange all 23 Mixed Friendlies without some only having 3 or 4 days gap, due to other commitments

### 7. Match Secretary's Report.

Colin George expressed concern over the difficulties of getting men members to play in League matches & intended to raise this issue at the Spring Meeting.

He noted that there were few fixtures after mid August & it was agreed to look at ways of arranging matches over that period.

The Ladies County Competitions have been quite difficult this year as the Majors will be played on a "play-by- date". The Minor competitions are being played over two days as usual and we are hosting the Over 70's pairs and the Ben Trips in July.

Judy had received advice on visually impaired players and this would be placed on the notice board for all to see.

As last years Christmas Dinner was such a success Roy volunteered to arrange the same for 2019.

# 12. Spring Meeting
